Course Syllabus – CNST 3205 Construction Safety Management

Course Description:

This course introduces students to OSHA regulations and industry practices related to creating and maintaining safe construction sites. At the completion of the course, students who attend classes will be eligible to receive an OSHA 30 Hour Course Completion Card.

This class will be conducted virtually but requires 100% attendance to receive the OSHA 30 Hour training card. If you will be unable to attend all classes and want the card, then you will need to take the course online.

Course Prerequisites:

CNST 3301 Construction Equipment and Methods

Textbook:

No textbook is required however we will be referencing OSHA standards from CFR 1926 – Code of Federal Regulations for Construction. This book can be purchased from the instructor at a significant discount or you can use the internet @ www.osha.gov

Course Learning Outcomes:

Upon the completion of the course students will demonstrate the ability to:

- 1. Describe OSHA's mission and Employee's Rights & Responsibilities under the Act.
- 2. Describe the process of an OSHA inspection
- 3. Describe the types and severity of penalties imposed on violators
- 4. Describe fundamental safe practices commonly implemented on construction sites
- 5. Describe ways employers can manage Safety & Health

In addition to the learning objectives above, this course is emphasizing Ethics, Safety, and Oral/Written Communication.

In lieu of class time; if a student currently holds an OSHA 30 Hour Certificate issued by an Approved OSHA Outreach Training Center you will be excused from participation in the class. You will however have to take the Final Exam and submit a Site-Specific Safety Plan.

 the SSSP.
- Make Up classes: No makeup classes will be offered this semester. If you miss a class and want the OSHA 30-hour-card then you must register for the online course. NO EXCEPTIONS.

Exam Policy:

Exams will include material covered in class discussions and homework assignments. Exam make-up's will be given only in the event of a verified emergency or doctor-verified sickness. The student is responsible for all reading assignments and class handouts whether or not covered in class or listed on the syllabus. Exams and Quizzes will be available on Blackboard after the class in which the topic was discussed.
