Construction Contract Administration CNST 6310

Course Description

This course introduces students to issues regarding administering construction contracts. It focuses on understanding of the purpose of contract documents, legal hierarchy of the documents, the interrelationships among the documents, liabilities accepted with each document, and typical challenges related to communications among the parties involved, establishing chain of commands, warranties, and progress/final payments.
